# 1. Opening of the Meeting

#### 3. Minutes

# 4. <u>Clarification of Quantitative Reasoning Compentencies - I-00-10, Document No. 00-10A and 00-10B</u>

George Doyle explained to the Executive Committee that Paul Eloe has concerns about implementation of the Quantitative Compentencies in the Math Department curriculum. The implementation would possibly cause the Math Department to change the current course or add a course to meet the requirement. The Executive Committee agreed.

## 5. Committee Reports

Robert Weaver reported for the Academic Policies Committee. The APC is revisiting the calendar issue. George Miner and Tom Westendorf have been asked to attend the next APC meeting to help answer a number of issues

about the Academic Calendar.

Fran Pestello reported for the Faculty Affairs Committee. The FAC has be working on the Faculty Workload Guidelines - I-00-13. Fran has contacted the Deans and requested they send to her what Faculty Workload requirements are for each unit. The FAC is also inviting the Faculty Development Committee to there next meeting to discuss their work on Faculty Workload.

On the issue of Role of Provost and Deans in Tenure Decisions - I-00-09. Professor Gerla is working with his sub-committee and will be draft the initial statement of standards for the FAC to review.

George Doyle reported the Student Academic Policies Committee. The SAPC revisited the Attendance Policy. There is no support on the Committee to make this change. It was suggested that the issue be suggested to Student Government Association.

The SAPC received a suggestion from the SGA is to consider to use the SGA Academic Senators for the Student Senators on the Academic Senate. The problem is that SGA has two senators, whereas the Academic Senate only needs one from each area.
