I. Course Review

1) THR 417/EDT 417: Theatre in Education (cross-listed)

A. Course Proposal Information:

1. Proposer and Program Director: Michelle Hayford was present for the committee's discussion, as well as co-proposer Treavor Bogard from Teacher Education.
2. Components: Arts, Crossing Boundaries-Integrative
3. Student Learning Outcomes: Diversity (advanced), Vocation (advanced)

B. Discussion:

1. The committee noted that both Student Learning Outcomes (SLOs) – Diversity and Vocation – are explicit and well-articulated in the proposal.
2. The inclusion of an experiential learning opportunity is also a positive aspect.
3. The courses will be open to all majors, not just Theatre and Teacher Education. It was noted that the second course objective covers how the reflective aspect of the Vocation SLO will be addressed. With the Vocation SLO being at the advanced developmental level, it was noted that any non-majors selecting these courses (Arts and Crossing Boundaries-Integrative) would likely have prior exposure to the SLO at the introductory or expanded level. In addition, the course outline has been structured with a gradual building of course content. For Teacher Education majors, students start field experience in the first year and would have exposure to the SLO. The proposers preferred not to limit the courses to Theatre and Education majors or with permission of the instructor. These courses are new and adjustments could be made, if needed, after offering them.
4. It was noted that 417 was selected as the course number due to availability. The decision to have a cross-listing between the units signals the importance of providing opportunities for team teaching to bring together different areas. Only one course will appear on a student's transcript, not the cross-listing. The committee felt that it would be valuable to be able to include interdisciplinary opportunities like this on the transcript and that it would be worth having further conversation.

C. Committee's Actions:

1. Motion: A motion was made and seconded to approve the course proposal as written. There was no further discussion.
2. Vote: 10-0-0 (in favor-against-abstention).
