**Opening prayer/meditation:** C. Krane opened the meeting with a prayer.

**Minutes:** The minutes of the December 12, 2014, ECAS meeting were approved with corrections.

**New Business:**

UNRC Call for Faculty Representation on the Presidential Search Committee: C. Krane reported that Steve Cobb, Chair of the Board of Trustees, was planning to “soft launch” the search committee on January 14, 2015, at the Board of Trustees’ retreat in Washington, DC. P. Benson explained that in addition to the Board’s agenda, the search committee would be meeting with the search firm that day and it would be preferable to have the three faculty representatives attend that meeting, if possible. ECAS approved Steve Cobb’s suggestion that C. Krane, President of the Academic Senate, be one of the faculty representatives. The UNRC process will be used to provide nominees for the other two faculty members. ECAS discussed at length the timing of this important UNRC call and the feasibility of completing the process in time for the two additional faculty members to attend the January 14<sup>th</sup> meeting. It was decided that the call would be extended through the holidays to allow sufficient time for faculty to nominate themselves and/or others. Every effort will be made to provide the opportunity for these two faculty members to attend the January 14<sup>th</sup> meeting either in person or via teleconference. E. Hicks will finalize the draft call and send it out by the end of the day. She will compile the names after the call closes on Tuesday, January 06, 2015. ECAS will meet on January 9th to discuss the nominees and choose the names of 4-5 faculty from the pool of nominations received through the UNRC process to forward to Steve Cobb and David Yeager (chair of the search committee), who will make the final selections.

The meeting was adjourned at 10:00 A.M.
