### **I. Course Reviews**

#### **1) ANT 350: Anthropology of Tourism**

##### **A. Course Proposal Information:**

1. Proposer: Stephanie Litka could not be present for the committee's discussion. Department chair Leslie Picca was present.
2. Components: Crossing Boundaries-Integrative, Diversity and Social Justice
3. Student Learning Outcomes (as proposed): Scholarship (advanced), Critical Evaluation of Our Times (advanced)

##### **B. Discussion:**

1. The Diversity Student Learning Outcome (SLO) is required for Diversity and Social Justice courses. The department made a request to withdraw the proposal to add the SLO.
2. In addition, the committee discussed the following minor revisions for the proposal:
  - a. Be more explicit about how the course will satisfy the Diversity and Social Justice component. In particular, the addition of a "social justice framework" as content in the course should be considered.
  - b. Change the developmental level of the other SLOs – Scholarship and Critical Evaluation of Our Times – from advanced to expanded.

##### **C. Committee's Actions:**

1. The committee did not take any action at this time because the proposal was withdrawn at the department's request. The proposal will be rolled back for revision.

#### **2) HSS 428: Research in Sport and Health Sciences**

##### **A. Course Proposal Information:**

1. Proposer: Anne Crecelius was present for the committee's discussion.
2. Component: Major Capstone
3. Student Learning Outcomes: Scholarship (advanced), Vocation (advanced)

##### **B. Discussion:**

1. The committee discussed a revision to articulate in the course description and in other relevant locations that this is an advanced (not an introductory) course. Language could start with "This course is a practical application of research methodology in the student's chosen profession and vocation."
2. In addition MTH 207 will be removed as a pre-requisite and will be replaced by senior standing or by permission.
3. The proposal was withdrawn for these revisions to be made.

**3) MKT 455: Marketing Analysis and Strategy**
