FOR RELEASE UPON RECEIPT

Congressman Charles W. Whalen, Jr. today sent President Johnson a letter urging him to direct the National Labor Relations Board (NLRB) and its Trial Examiner to give top priority over all other pending cases to the National Cash Register Company union representation issue now before the NLRB.

Whalen said in the letter that the NLRB is responsible for the long delays in resolving this issue and thus has an obligation to the Dayton community to expedite the case.

The Dayton Congressman yesterday criticized the NLRB for its handling of the case in a sharply-worded speech on the House floor.

Whalen enclosed a copy of that speech in his letter to the President.
