- ECAS Consultation:
 - Draft Staff Promotion Policy
 - Vigorous and substantial discussion; the following questions emerged:
 - o Has this policy been benchmarked to other HR processes at comparable institutions? What are the results of that benchmarking?
 - In arriving at this draft policy, what other options were considered? ECAS is particularly interested in hearing about options that were considered and rejected under #2 Waiver of Posting Process.
 - Was a process for Interim appointments discussed? What were the results of that discussion?
 - If the processes of appointments are inflexible at the lowest levels, that is, a search is most often required, should that also not hold at the highest levels?
