- Includes provision to comply with constitution to ensure only faculty with tenure serve as officers of the Senate and a provision if there are fewer than three tenured-members on ECAS.
- Includes a clarification on length of terms for sabbatical replacements to ECAS
- Includes update to election schedule for members of ECAS due to constitutional amendment.

New Business

- **DISCUSSION:** Adding request for information of IT resources within CIM system (Guest: Tom Skill).: Tom shared that it would be helpful for UDIT to have information regarding the IT resources that would be required for the implementation and delivery of program changes and the formation of new programs, especially what would be required of e-learning staff as well as software requirements; ECAS agreed that such a change to CIM would be beneficial and discussed the logistics of making a recommendation and presenting it to the full Senate: Vote to recommend this change was unanimously in favor of the change and that it be announced to the Senate in January 2022
- **UPDATE:** Next steps for SAPC and priorities for Spring 2022 action at Senate.: Sam shared discussions that he has had with Sharon Gratto regarding having two separate policy changes related to SET: delivery of SET and the use of SET for merit/tenure/promotion. We also discussed the need for FAC to weigh in on the latter.
- **DISCUSSION:** Expanding midterm grading policy for all undergraduate students.: We discussed some of the downside of making such a policy change (e.g., there are many times throughout the semester that faculty are asked to provide grades, adding to faculty workload, especially those teaching more courses, such as lecturers). We also discussed the positives of making such a change, continuing the discussion we had last week. The discussion was rich and robust, including how best to address this issue (e.g., which standing committee should perform this task, forming a task force, etc.). One idea was to have FAC take this on as part of a larger discussion on how we evaluate teaching/research/service, although this may be too much to ask of the committee right now. **ACTION ITEM: Discuss this issue with chairs in January.**
