- Discussion of how to raise awareness and communicate the policy prior to a vote
- References to applicable Senate documents have been added. This policy cannot currently replace all of those policies since key language is contained in those; but where inconsistent this policy replaces relevant sections of those. Discussion: Including the important parts of those policies into this policy would mean that it could replace all of those policies; working group is now being asked to do this work.
- Discussion: It might be valuable to run a test evaluation of a faculty member using SFT, self-reflection, etc. to see what the suggested process looks like in practice.
- This draft will be discussed (but not voted on yet) at the March 24 Academic Senate meeting.
- Question/discussion of whether the current tool allows for individual evaluation of multiple instructors, when relevant for a class.
- ECAS read the document and made some edits for clarity and consistency. For example, clarifying that both the SFT and faculty teaching reflections must be used as part of the evaluation of teaching effectiveness.
- Discussion of some additional communication/listening sessions ahead of a vote at the April 14 Academic Senate meeting. Anticipated questions include what the questions and tool will look like. Sessions will likely be scheduled for early April.

- Question: do either of these charts apply to graduate certificates? Answer, yes, to an extent. But they were based on documents that apply to undergraduates.

- Discussion of possibility of removing CAP 4-year review, while remaining in compliance with all accreditation requirements. Would removing that review process diminish the impact of CAP for student learning outcomes? CAP 4-year reviews have been noted as onerous in recent surveys on workload and CAP. Comment that CAP assessment varies across campus and it would be helpful to have more robust systems to facilitate this reporting of data. Comment that CAP is distinctive to UD and having routine assessment of it is important; however, the current system, especially with 4-year cycles, is not sustainable.

 - CAP assessment underway, with leadership by Nancy Haskell.
 - Good response rates.
 - Some initial qualitative data: majority of all responding groups see value in CAP, including the opportunity to explore interests; concerns about the time, especially assessment time, needed for CAP courses; some student observations include how time-consuming CAP courses can be compared to the courses in their major.
 - Also assessing the qualitative data and other documents that have been shared from campus offices.
